

TERMS & CONDITIONS: BIG PLAYER BONUS PROMOTION

for residents of CA, CO, MT, NY, OR and WY

The following terms and conditions shall apply to the Big Player Bonus Promotion (the “Promotion”) being offered by Game Play Network, Inc. (“b spot”). The Promotion (i) supersedes the Big Player Bonus Promotion published on March 29, 2020, and (ii) was revised on October 31, 2022, at 5pm PDT, and (iii) was revised again on January 5, 2023 at 5pm PDT, and (iv) was revised again on December 6, 2023 at 8:18am PST, and (v) was revised again on December 15, 2023 at 8:19am PST, and (vi) was revised again on January 11, 2024 at 12:19pm PST, and (vii) was revised again on February 16, 2024 at 11:20am PST (the “Effective Time”), and (viii) was revised again on February 20, 2024 at 12:35pm PST, and (xi) was revised again on February 26, 2024 at 12:46pm PST (the “Effective Time”).

1. Eligibility Requirements. To be eligible for the Promotion, an individual must (a) have a valid advance deposit wagering account with b spot (a “Player”), and (b) be a resident of California, Colorado, Montana, New York, Oregon or Wyoming, and (c) purchase a wager package costing ten dollars (\$10), twenty dollars (\$20), forty dollars (\$40) or one hundred dollars (\$100) (the “Package”) during the term of the Promotion (the “Promotion Period”) that returns a payout per package as set forth below (each, a “Qualified Payout”).

2. Cash Payments. b spot will add a cash payment (the “Payment”) to the Player’s account by crediting the account, within a commercially reasonable time, as follows:

- ten dollar (\$10) packages:
 - i. that yield a Qualified Payout of zero dollars (\$0) to one dollar ninety-nine cents (\$1.99) will receive a “top up or over” Payment equal to the amount by which two dollars (\$2) exceeds the Qualified Payout, or
 - ii. that yield a Qualified Payout of twenty-eight dollars (\$28) to fifty-nine dollars ninety-nine cents (\$59.99) will receive a “top up or over” Payment equal to the amount by which sixty dollars (\$60) exceeds the Qualified Payout, or
- twenty dollar (\$20) packages:
 - i. that yield a Qualified Payout of zero dollars (\$0) to three dollars ninety-nine cents (\$3.99) will receive a “top up or over” Payment equal to the amount by which four dollars (\$4) exceeds the Qualified Payout, or
 - ii. that yield a Qualified Payout of sixty-six dollars (\$66) to one hundred nineteen dollars ninety-nine cents (\$119.99) will receive a “top up or over” Payment equal to the amount by which one hundred twenty dollars (\$120) exceeds the Qualified Payout, or
- forty dollar (\$40) packages:

- i. that yield a Qualified Payout of zero dollars (\$0) to seven dollars ninety-nine cents (\$7.99) will receive a “top up or over” Payment equal to the amount by which eight dollars (\$8) exceeds the Qualified Payout, or
- ii. that yield a Qualified Payout of ninety-three dollars (\$93) to two hundred thirty-nine dollars ninety-nine cents (\$239.99) will receive a “top up or over” Payment equal to the amount by which two hundred forty dollars (\$240) exceeds the Qualified Payout, or
- one hundred dollar (\$100) packages:
 - i. that yield a Qualified Payout of zero dollars (\$0) to nineteen dollars ninety-nine cents (\$19.99) will receive a “top up or over” Payment equal to the amount by which twenty dollars (\$20) exceeds the Qualified Payout, or
 - ii. that yield a Qualified Payout of two hundred five dollars (\$205) to five hundred ninety-nine dollars ninety-nine cents (\$599.99) will receive a “top up or over” Payment equal to the amount by which six hundred dollars (\$600) exceeds the Qualified Payout.

3. Use of the Payment. The Payment may be withdrawn in cash, or used for more game play, in whole or in part, after it has been credited to the Player’s account.

4. General. The b spot Terms of Use posted on www.bspot.com and in the b spot mobile application (the “Terms of Use”) govern this Promotion and your use of the b spot Service (as defined in Section 1 of the Terms of Use). b spot may disqualify any person from the Promotion in the event that the person: (i) violates the Terms of Use; (ii) engages in fraudulent or deceptive behavior; and/or (iii) attempts to defeat or circumvent any of the promotional rules or restrictions. This Promotion will apply to any Package purchased after 12:19pm PST on January 11, 2024, provided, however, that b spot may suspend, modify or cancel the Promotion, or set an end date for the Promotion Period, at any time, for any reason, and without prior notice. The following persons shall not be eligible to participate in the Promotion: (a) any employee of b spot; (b) any person prohibited from opening an account or wagering with b spot pursuant to the Terms of Use or applicable law; (c) any person residing in a State that is not part of this Promotion; and/or (d) any person on b spot’s self-exclusion list. An account holder eligible for this Promotion cannot transfer his/her eligibility to another account holder.
